#### Call to Order

# **OLD BUSINESS**

- I. Ting Construction
  - A. Ting started to dig in LHMD. The construction/digging is expected to continue through Springtime.
- II. City of Centennial ADA Compliant Sidewalk Project
  - A. Centennial continues its ADA sidewalk accessible project and all entrance ways appear to be complete.
  - B. There continues to be damage to the perimeter landscape due the sidewalk repair/ADA compliant process. C. Mcdonnell to continue to attempt to contact the city to make sure the damaged landscaping is repaired once the project is complete.
  - C. The contractors also added a wall under the LHMD monument sign taking away part of the LHMD property. Discussion of landscaping possibilities for this area will take place closer to Spring.
- III. Landscaping
  - A. There are dead bushes and trees around the perimeter that were lost due to the 1<sup>st</sup> hard freeze that will need to be replaced. Bids will be obtained in March or April.

## **NEW BUSINESS**

- 2020 Election/DOLA
  - A. The Board reviewed and discussed the proposal by Community Resource Services for election processing for the upcoming May 2020 election. It was unanimously approved to move forward with the proposal.
