Call to Order

The meeting was called to order by Chairman McDonnell at 6:33 p.m. after declaring a quorum of Directors present as reflected by this record.

- I. The November meeting minutes were reviewed and signed by the Board. Motioned for approval by A. Bobb, seconded by C. McDonnell.
- II. The November 2013 Treasurer's report was reviewed by the Board. Motioned for approval by A. Bobb, seconded by D. Greenleaf.

OLD BUSINESS

- I. Perimeter update:
 - A. C. McDonnell reviewed the progress on the perimeter update that has occurred since the Board's November meeting. Construction continues.
 - B. Remaining holes in the fence will be filled in.
 - C. The columns were mistakenly acid-washed but will be fixed. Discussion with Standard Fence will be held to discuss how this issue will be resolved.
 - D. The Board needs to find stain for the front of the fence. They are working on obtaining color samples.
 - E. A resite survey must be completed because the project is over 30 days on Easter Avenue. Completion should be by end of January, 2014.
 - F. Electric box will be enclosed/hidden with a fence surround.
 - G. Retaining wall along Briarwood and Holly Streets is being redone.

- H. Once monuments are complete, the pots will be placed on top of columns depending on weather.
- I. B. Thomsen asked about various branches left on perimeter and C. McDonnell reported that the fence company would be cleaning up all branches/debris.

NEW BUSINESS

- I. Perimeter update:
 - A. C. McDonnell reviewed the progress on the perimeter update that has occurred since the Board's November meeting. Construction continues to go well.
 - B. Landscape review for plant materials for the perimeter will be conducted during January and February 2014.
 - C. Landscape budgeting will happen during February and March. American Quality Landscape and Sage Design will be involved in this process.
- II. South Holly Baptist Church is no longer available for Metro or HOA meetings on Wednesdays. The Directors will work with church to set a new day.
- III. J. George discussed the adjustment to Capital Improvement Fund on the 2014 proposed Budget increase to \$125,000.
- IV. J. George advised that the Certificate of Mill Levy had been filed 12/17/13.
- V. Resolutions pertaining to the setting of Mill Levy, Adoption of Budget, and Appropriate Sums of money were presented and approved unanimously.
