- II. A portion of the fence needs repair at 7034 Grape Way and along Holly at Briarwood.D. Lee called Discount Fence for a proposal. Discount was asked to walk the entire perimeter to review and propose all repairs needed to the posts.
- III. Cameron McDonnell requested to be involved with the selection of summer flowers for 2012. Chairman Lee will ask Urban Farmer to have their proposed list of summer flowers available for the February meeting. Following review, the Board will decide if changes are necessary and Mr. McDonnell's participation is encouraged.

    - xv. Continuity of materials install
    - xvi. Pre-formed concrete walls, color / stamped
