Call to Order

The meeting was called to order by Chairman McDonnell at 6:32 p.m. after declaring a quorum of Directors present as reflected by this record.

- I. The December 18, 2013 and January 20, 2014 meeting minutes were reviewed and signed by the Board. Motioned for approval by J. George, seconded by C. McDonnell and D. Greenleaf.
- II. The January 2014 Treasurer's report was reviewed by the Board. Motioned for approval by D. Greenleaf, seconded by A. Bobb.
- III. J. George reported that we will be shutting down the old checking account with Wells Fargo.
- IV. It was reported that we will know by the end of March 2014 whether our request for exemption from the financial audit is approved.

- II. Perimeter update:

- C. C. McDonnell has stain samples for the front of the fence for the Board's review.

- II. Landscape plan:
 - A. C. McDonnell reported that the landscape plan was to be produced today, but it will be tomorrow, January 21st and brought to the next Board meeting. It will then be reviewed by the Board and changes will be noted.
 - B. The landscape plan shows the removal of the retaining wall, but it will remain.
 - C. Tree choice will be alternated in some areas and update the tree size to the larger size.
 - D. Bids will be requested from American Quality, ETI, JBK and ???
 - E. The irrigation project should be complete by the end of May.
