  - A. The issue of no power to the area of the monument sign continues. An electrician came to look at and it was determined that the pedestal is owned by LHMD and needs to be repaired. A discussion was held about the approximate cost to fix the issue. A. Bobb motioned to approve the procession with repair and H. LeMay seconded. The motion carried.

  - A. A. Bobb reported that all election items have been completed with the help of CRS. The invoice for election publication was forwarded to the Treasurer for payment.
