#### Call to Order

The meeting was called to order by Chairman McDonnell at 6:31 p.m. after declaring a quorum of Directors present as reflected by this record.

- I. The May 2017 Treasurer's report was presented by S. McDonnell and reviewed by the Board. H. LeMay moved to approve and C. McDonnell seconded. The motion was unanimously carried.
- II. The January 2017 meeting minutes were tabled for review.
- III. The May 2017 meeting minutes were reviewed by the Board. H. LeMay moved to approve and S. McDonnell seconded. The motion was unanimously carried.
- IV. S. McDonnell reported that the filing of the audit exemption was successfully accepted by DOLA as there has been no word indicating otherwise.

#### **OLD BUSINESS**

- I. Retaining Wall LMHD Bordering Residential Property
  - A. C. McDonnell reported that the wall was repaired the week of June 12<sup>th</sup>.
- II. Retaining Wall S. Holly Street
  - A. McDonnell reported that he is still researching and now the City of Centennial/Public Works is searching for the permit for the subcontractor that caused the damage so that LHMD can get the damaged area repaired.
- III. Landscaping/Parameter Flowers
  - A. C. McDonnell reported that the parameter flowers have been planted.

#### **NEW BUSINESS**

- I. Trash/Waste Collection
  - A. H. LeMay reported that she was contacted about obtaining one trash/waste company for our neighborhood instead of having several. Discussion was had, C. McDonnell indicated this was an HOA issue, and no action was taken.
- II. City of Centennial Code Enforcement/Nuisance Regulations
  - A. Outdoor Junk and Inoperable Vehicles
    - A. Bobb reported that the City of Centennial updated their Nuisance Regulations/Code Enforcement which now allows Code Compliance officers to enforce outdoor storage/stockpiling and junk/inoperable vehicle violations within private yards if the City receives a complaint and permission to observe the suspected nuisance.

- B. Proper Storage of Garbage Cans
  - I. Municipal Code now requires garbage cans to removed within 24 hours of placement on public streets.
  - II. Garbage cans must be stored in areas not visible from the street and can lids must be utilized.
