 - B. There's a tree at Forest and Easter that needs to be replaced.
 - C. The landscaping at the Briarwood monument sign needs to be redone.
 - D. New mulch will need to be added to the entire perimeter.
 - E. Bids for landscaping will be obtained for review.
- II. New Board Member Appointment
 - A. The Board discussed the need to appoint a new Board member soon due to Betty Thomsen's unfortunate absences and her inability to return. A. Bobb will obtain information for what is required to appoint a new member for the August meeting.
- III. House Bill 17-1297 Special District Board Member Compensation
 - A. The Board discussed the Colorado General Assembly's enactment of House Bill 17-1297 wherein it was enacted to allow for an increase in pay to Board Members' attendance at Special District
