I. Perimeter Update – The fence construction is complete. Staining of the fence will be completed soon dependent upon weather. The brick columns will be wrapped to protect the brick before staining. McDonnell addressed the comment and stated the test color had only one coat and the final color will look much better once complete with two coats.

I. Fence – the cable/telephone box on Holly Street has been enclosed with fencing material. Gate hinges will be installed on the box so that public utility companies may obtain access.

- II. Perimeter Update/Landscaping The landscape design plan was received from Sage Design. The landscaping will go to bid with four different landscape companies. Bids are to be submitted by March 30th and each bid will be reviewed once received.
- III. Landscape Plan All information appeared to be correct with the exception of the irrigation statements. Additional plants were added to the plant list. Irrigation needs to be completed by Mother's Day.
