#### **Call to Order**

- I. Landscaping/Backflow testing:

- II. Lighting on Holly Street:
  - A. C. McDonnell suggested that additional lighting be added to the fence columns along Holly Street as it is very dark. He indicated that the transformer is strong enough to support the lighting to all of the columns along Holly Street and cost should not be more than about \$550. B. Thomsen moved to approve C. McDonnell adding the lighting to the columns along Holly Street and D. Greenleaf seconded motion carried.
